CHARTER OF THE CGIAR SYSTEM ORGANIZATION

CGIAR is a global research partnership for a food-secure future. CGIAR science is dedicated to transforming food, land and water systems in a climate crisis, in order to reduce poverty and inequity, enhance food and nutrition security, and improve natural resources and ecosystem services. Its research is carried out by 15 CGIAR centers in close collaboration with hundreds of partners, including national and regional research institutes, civil society organizations, academia, development organizations and the private sector.

CHARTER OF THE CGIAR SYSTEM ORGANIZATION

This Charter was agreed between the CGIAR System's Funders and 15 Centers on 16 June 2016 and with effect from 1 July 2016 as the governing instrument of the CGIAR System Organization. It was last amended with effect from **[15 June] 2026** as the legal instrument governing the CGIAR System Organization and establishing the CGIAR Integrated Partnership.

CGIAR System Organization

Preamble

1. The Consultative Group on International Agricultural Research was established as a global partnership in 1971. After several reforms, in December 2009, a new framework of overarching principles was agreed between the centers and the funders to give rise to a reformed CGIAR as set forth in the CGIAR Joint Declaration. On April 29, 2010, the then-called Consortium of International Agricultural Research Centers (which operated under the name “CGIAR Consortium”) was established as a joint venture between the 15 International Agricultural Research Centers supported by the Consultative Group on International Agricultural Research. On July 20, 2012, the CGIAR Consortium obtained international organization status pursuant to an agreement establishing the Consortium of International Agricultural Research Centers as an international organization (“International Organization Agreement”), and operated in accordance with the rules set forth in its constitution. In 2016, the Centers and Funders agreed to a CGIAR System Framework that provides for a CGIAR Council and a CGIAR System Organization. The CGIAR System Organization operates in accordance with this CGIAR System Charter, which replaced in its entirety the constitution of the CGIAR Consortium. The legal name of the Consortium of International Agricultural Research Centers was changed to the CGIAR System Organization upon the amendment of the International Organization Agreement on 21 November 2016.
2. The CGIAR System Organization is part of a broader CGIAR System whose structure is set forth in Article 2 of the CGIAR System Framework. The purpose of the CGIAR System is to advance science and innovation to transform food, land and water systems in a climate crisis, in order to reduce poverty and inequity, enhance food and nutrition security, and improve natural resources and ecosystem services.

Article 1. Legal Status

The CGIAR System Organization is an independent international organization with such international legal personality as may be necessary for the exercise of its functions and powers, and the fulfillment of its purposes, including without prejudice to the generality of the foregoing, the legal capacity:

- a) to enter into treaties, agreements, arrangements and contracts
- b) to acquire and dispose of movable and immovable property
- c) to institute and respond to legal proceedings.

Article 2. Definitions

In this Charter, unless the context otherwise requires:

- a) “Active Observers” means those entities identified in Article 7 and which have the right to participate in deliberations of the CGIAR Board and to propose agenda items and make presentations for such deliberations. An Active Observer does not have a right to vote.
- b) “Centers” means those research organizations with legal personality that are recognized as CGIAR Research Centers contributing knowledge, technical expertise, and resources in support of the CGIAR Strategy and Results Framework. Each organization is an independent legal entity with its own governing board, governing instruments and host country agreements. As of the date of agreement of this Charter, the following 15 research organizations are recognized as CGIAR Research Centers: Africa Rice Center, also known as AfricaRice, Bioversity International, Center for International Forestry Research (CIFOR), International Center for Agricultural Research in the Dry Areas (ICARDA), International Centre for Research in Agroforestry (ICRAF), also known as World Agroforestry Centre, International Center for Tropical Agriculture (CIAT), International Crops Research Institute for the Semi-Arid Tropics (ICRISAT), International Food Policy Research Institute (IFPRI), International Institute of Tropical Agriculture (IITA), International Livestock Research Institute (ILRI), International Maize and Wheat Improvement Center (CIMMYT), International Potato Center (CIP), International Rice Research Institute (IRRI), International Water Management Institute (IWMI), and International Center for Living Aquatic Resources Management (ICLARM), also known as WorldFish.
- c) “CGIAR Board” means the governing body of the CGIAR System Organization and of the Integrated Partnership, described in Articles 7-9.
- d) “CGIAR Board Audit Finance and Risk Committee” or “CGIAR AFRC” means the audit, finance and risk committee of the CGIAR Board referred to in Article 9.
- e) “CGIAR Council” means the strategic decision-making and oversight body described in Articles 3-8 of the CGIAR System Framework.
- f) “CGIAR Executive Managing Director” or “Executive Managing Director” means the executive director of the CGIAR System Organization as described in Article 12.
- g) “CGIAR’s Independent Advisory and Evaluation Service” or “IAES” provides operational support as the secretariat for the Independent Science for Development Council and the Standing Panel on Impact Assessment, and implements CGIAR’s multi-year, independent evaluation plan as approved by the CGIAR Council.

- h) “CGIAR Integrated Partnership” or “Integrated Partnership” means a federated group of Centers and the CGIAR System Organization, united by common values and principles, and committed to achieving, through integration and coordination, synergies that enhance the Centers’ individual and collective contributions to fulfilling the purpose of the CGIAR System.
- i) “CGIAR Internal Rules Framework” means the framework established by the Integrated Partnership that sets out its approach regarding the development, adoption, applicability, and enforcement of CGIAR Policies and Procedures, as amended from time to time.
- j) “CGIAR Office” means the office described in Article 11.
- k) “CGIAR Policies and Procedures” means all mandatory internal rules that apply across the Integrated Partnership (e.g., CGIAR frameworks, policies, procedures, etc.); for the avoidance of doubt, they do not include the CGIAR System Framework or the CGIAR System Charter.
- l) “CGIAR Portfolio” means the research and other programs carried out by the Centers and the CGIAR System Partners in support of the CGIAR Strategy and Results Framework and which are supported by (i) the CGIAR Trust Fund and/or (ii) bilateral sources contractually aligned to such programs.
- m) “CGIAR Research” means the research and innovation carried out by the Centers and the CGIAR System Partners in support of the CGIAR Strategy and Results Framework.
- n) “CGIAR Strategy and Results Framework” means one or more documents setting forth the common goals, strategic objectives and results to be achieved by the CGIAR System. The documents may be revised and updated from time to time.
- o) “CGIAR System” means, when taken together as a collective whole, a reference to the Centers, the Funders, the CGIAR Council, the CGIAR System Organization, the advisory bodies to the CGIAR Council, and CGIAR Research.
- p) “CGIAR System Charter” or “Charter” or “Charter of the CGIAR System Organization” means the legal instrument governing the CGIAR System Organization and establishing the Integrated Partnership, as may be amended from time to time in accordance with its terms.
- q) “CGIAR System Framework” means the framework for the CGIAR System, as may be amended from time to time in accordance with its terms.
- r) “CGIAR System Organization” or “System Organization” means the international organization governed by the CGIAR System Charter, with its organs being the CGIAR Board and CGIAR Office.

- s) “CGIAR System Partners” means all organizations external to the CGIAR System that contribute to, or support the delivery of, the CGIAR Strategy and Results Framework. They include national agricultural research and extension systems, universities and advanced research institutes, policy bodies, global and regional fora, intergovernmental organizations, non-government organizations, private-sector companies, farmers/producers and consumers.
- t) “CGIAR Trust Fund” means the trust fund(s) established by the trustee for contributions from Funders to provide funding for the activities of the System Organization and for CGIAR Research.
- u) “Ethics and Business Conduct Function” means the arrangements agreed between the CGIAR Board and the Centers to foster a system-wide culture of ethics, integrity, and accountability, and that reports to the CGIAR Board through the CGIAR AFRC.
- v) “Funders” means those entities that contribute funding to Centers in support of the CGIAR Strategy and Results Framework and to the activities of the CGIAR System Organization, either through the CGIAR Trust Fund or through bilateral contributions.
- w) “Independent Science for Development Council” or “ISDC” means an external, impartial standing panel of experts in science and development subject matters (including food, land and water systems innovation matters) appointed by the CGIAR Council and accountable to it, with the responsibility of providing rigorous, independent strategic advice to the CGIAR Council and, based on decisions taken by the CGIAR Council, the broader CGIAR System as a whole.
- x) “Internal Audit Function” means the arrangements agreed between the CGIAR Board and the Centers to provide independent and objective system-wide assurance and advisory services, and reports to the CGIAR Board through the CGIAR AFRC.
- y) “Partnership Forum” means a forum for the CGIAR System and CGIAR System Partners to discuss and exchange views about the CGIAR System and the CGIAR Strategy and Results Framework within the scope set forth in the CGIAR System Framework.
- z) “Standing Panel on Impact Assessment” or “SPIA” means an external, impartial standing panel of experts in impact assessment subject matters appointed by the CGIAR Council and accountable to it, with responsibility to provide rigorous, evidence-based and independent strategic advice to the CGIAR System on (i) efficient and effective impact assessment methods and practices, including those measuring impacts beyond contributions to science and economic performance, and (ii) on innovative ways to improve knowledge and capacity on how research contributes to development outcomes.

- aa) “Unrestricted Funding” means funding from the CGIAR Trust Fund that has not been designated by a Funder for a specific Center or research program.

Article 3. CGIAR Council

The CGIAR Board shall, in accordance with this Charter and the CGIAR System Framework, work with the CGIAR Council, which undertakes the functions set forth in the CGIAR System Framework, in order to ensure alignment of direction, strategy and resources. The CGIAR Council is supported by the CGIAR Office as set forth in Article 11.

Article 4. Collaboration between Centers

- 4.1 The Centers recognize the benefits of collaboration in CGIAR Research in general, and specifically in the CGIAR Portfolio, and working jointly within the Integrated Partnership to achieve the goals of the CGIAR Strategy and Results Framework facilitated by the CGIAR Board. The CGIAR Board will keep under review the effectiveness of the system, its reputation for excellence, and the capacity, skills and organizational structure of the Centers with a view to their collective ability to ensure results and the continued relevancy of research for development in food, land and water systems. The CGIAR Board may recommend to a Center’s Board actions that may be considered to better respond to the evolving challenges [REDACTED] research, taking into account any recommendations of the CGIAR Council.

Initial CGIAR Research Centers

- 4.2 The initial 15 CGIAR Research Centers are listed in Article 2(b).

Recognition of New Centers

- 4.3 The CGIAR Board may agree, in consultation with the CGIAR Council, to admit and recognize additional research organizations as CGIAR Research Centers, provided that:
- a) the then-current Centers approve the proposal by a two-thirds majority vote;
 - b) the new Center meets general criteria for recognition established by the CGIAR Board, in consultation with the CGIAR Council; and
 - c) each such new Center agrees formally in writing to be bound by the provisions of this Charter, any and all applicable CGIAR Policies and Procedures and the CGIAR System Framework.

Voluntary Withdrawal from the CGIAR System

- 4.4 Any CGIAR Research Center may choose to disassociate itself from the CGIAR System by giving at least one year's written notice to that effect to the Chair of the CGIAR Board.

Ending recognition as a CGIAR Research Center

- 4.5 The CGIAR Board may decide to end the recognition of a Center as a CGIAR Research Center, with the agreement of two-thirds of the other CGIAR Research Centers and in consultation with the CGIAR Council, in cases where such Center has failed to:

- a) comply with funding agreements with the System Organization;
- b) comply with applicable CGIAR Policies and Procedures;
- c) perform adequately in accordance with the CGIAR System's risk management framework; or
- d) ensure results or the continued relevancy of agricultural research for development under CGIAR Research,

and it has been unable or unwilling to take the necessary remedial actions as determined by the CGIAR Board in consultation with the CGIAR Council.

- 4.6 Any admission, withdrawal or termination of recognition of a Center as a CGIAR Research Center shall be formally notified in writing to the Depository of the International Organization Agreement. Such a Center can still be a CGIAR System Partner and contribute as such to CGIAR Research.

Article 5. Role of Centers

- 5.1 A CGIAR Research Center shall have the following rights in relation to the CGIAR System:

- a) conduct CGIAR Research and submit proposals for CGIAR Research for consideration and potential funding from the CGIAR Trust Fund
- b) contribute to agenda setting of the CGIAR System including foresight studies, and be involved in reviewing and updating the CGIAR Strategy and Results Framework and establishing CGIAR Research
- c) propose and approve amendments to this Charter, in accordance with the process stated herein
- d) retain their own means of funding, including, but not limited to, bilateral funding
- e) individually maintain the right to discontinue voluntarily its recognition as a CGIAR Research Center of the CGIAR System by giving at least one (1) year's prior notice to allow the orderly transition of activities involving CGIAR Research
- f) raise with the CGIAR Board or with the CGIAR Council any concern as to

whether the CGIAR System Organization is operating in accordance with this Charter or the CGIAR System Framework

- g) seek and receive funding for CGIAR Research from sources other than the CGIAR Trust Fund
- h) participate, as determined by its Board, in shared services and other related non-mandatory activities or policies
- i) identify needs for and approve CGIAR Policies and Procedures, or material amendments thereto, in accordance with the CGIAR Internal Rules Framework
- j) for the Chair of its Board to take up a seat on the CGIAR Board as an ex officio voting member

5.2 A CGIAR Research Center shall have the following responsibilities:

- a) act in accordance with this Charter, CGIAR Policies and Procedures and the CGIAR System Framework, and monitor compliance therewith
- b) without prejudice to the ability to raise concerns with the CGIAR Board or the CGIAR Council, comply with the resolutions of the CGIAR Board
- c) provide to the CGIAR System Organization all relevant information and support documentation on CGIAR Research, to facilitate the reporting requirements as agreed between the CGIAR Board and the CGIAR Council
- d) collaborate with the CGIAR Board, the Executive Managing Director and other Centers in order to achieve synergies through integration and coordination, and in all those cases where joint action is needed
- e) make all reasonable efforts to foster the purpose of the CGIAR System
- f) ensure that the Chair of its Board serves as an ex officio voting member of the CGIAR Board

Article 6. Structure and Governance of the CGIAR System Organization

The CGIAR System Organization shall be comprised of:

- a) the CGIAR Board
- b) the CGIAR Office

Article 7. Composition of the CGIAR Board

7.1 The CGIAR Board shall be the governing body of the CGIAR System Organization and of the Integrated Partnership.

7.2 The CGIAR Board shall consist of voting members as follows:

- a) the Chairs of all CGIAR Center Boards, who shall serve on the CGIAR Board as ex-officio members; and

The Integrated Partnership Board shall comprise a Chair, the Chair of the IPB AFRC and a number of other voting members that equals the number of Center Boards¹, subject to its membership being at a sufficient number to deliver on its responsibilities. Taken as a collective whole, the Integrated Partnership Board members will have the diversity, skills, experience and gravitas required to enable the Integrated Partnership Board to discharge its responsibilities under this Charter. Employees of Centers and the System Organization are not eligible to sit on the Integrated Partnership Board as voting members. At least one expert in organizational management and one expert in financial management will be voting members of the Integrated Partnership Board.¶

b) six independent members who shall meet the following independence criteria²:

- i. no material business relationships within the last two years, including as an adviser, client and/or supplier of any CGIAR Center or the CGIAR System Organization or CGIAR Funder, or Board member of a CGIAR Center or a CGIAR Funder; and
- ii. not a former employee of any CGIAR Center, the System Organization or a CGIAR Funder within the last three years.

7.3 The CGIAR Board shall appoint its Chair, Vice-Chair and Chair of the CGIAR AFRC from amongst its independent members.

7.4 The Executive Managing Director of the System Organization shall serve on the CGIAR Board as an ex-officio non-voting member.

7.5 Taken as a collective whole, the CGIAR Board members shall have the diversity, skills, experience and gravitas required to enable the CGIAR Board to discharge its responsibilities under this Charter. The profile of the CGIAR Board shall be approved by the CGIAR Board following consensus of the CGIAR Council.

7.6 The independent members of the CGIAR Board shall be appointed by the CGIAR Board from nominations made by the CGIAR Board's Nominations Committee.

7.7 Independent members of the CGIAR Board shall be appointed for a term of up to three years and may be reappointed. The maximum number of years such members may serve is six years. In the event there are extenuating circumstances that require extension beyond the six-year term, a member may be reappointed for an additional term not to exceed one year.

7.8 The following shall be invited by the Chair of the CGIAR Board as Active Observers at CGIAR Board meetings held for the purposes of discharging the CGIAR Board's responsibilities under Article 8:

- a) 2 CGIAR Council voting members
- b) 1 representative of ISDC

7.9 The Chair may invite other persons as relevant to attend CGIAR Board meetings in line with the CGIAR Board's Rules of Procedure.

7.10 All CGIAR Board members and Active Observers shall act in good faith in the interests of the CGIAR System Organization and the CGIAR Integrated Partnership as a whole. When a member of the CGIAR Board sits on the

Article 9. CGIAR Board Operations

Meetings

- 9.1 The CGIAR Board shall meet as often as necessary, ideally on a quarterly basis but, in any case, not less than twice per year in ordinary session. The rules of procedure of the CGIAR Board shall provide for the location and arrangements for the conduct of meetings, including the convening of extraordinary meetings.
- 9.2 CGIAR Board meetings may be held face-to-face, by video or audio-conference or any other electronic communication medium that allows CGIAR Board members to follow and contribute to discussions as they occur in real time.
- 9.3 The CGIAR Board may conduct business only when the following are present:
For the purpose of calculating quorum, each CGIAR Board voting member who also serves as a Center Board Chair shall be counted based on the number of Centers whose Board they chair³:
 - a) at least two-thirds of the ex officio voting members, and
 - b) at least two-thirds of the independent members, including the Chair or Vice-Chair of the CGIAR Board or a temporary chairperson appointed amongst the members present, if needed.

Where a vacancy exists in the CGIAR Board's membership, that vacancy does not count towards the total voting membership for the calculation of quorum.

Decision-making during a meeting

- 9.4 The CGIAR Board shall use best efforts to make all decisions by consensus. The Chair shall use best efforts to ascertain a consensus after consultation with other members of the CGIAR Board. For the purposes of this Charter, consensus is a procedure for adopting a decision when no voting member in the decision-making process formally objects to a proposed decision or calls for a vote. It does not necessarily imply unanimity. A dissenting voting

9.8 All decisions of the CGIAR Board shall be recorded in a summary of the CGIAR Board meetings approved by the CGIAR Board, communicated, published and retained in the permanent records of the CGIAR System Organization.

Decision-Making without a meeting

9.9 In the circumstances set forth in the rules of procedure, the CGIAR Board may be requested to approve a decision by electronic means in lieu of a meeting.

Closed sessions

9.10 At the determination of the Chair, the CGIAR Board may conduct business in a closed (executive) session of voting members where ex-officio non-voting members may be present unless the Chair decides otherwise. Active Observers may be invited to attend the closed session unless the Chair decides otherwise. The Chair may invite others to attend as appropriate in the circumstances. The outcomes of a closed session shall be recorded in the meeting summary if a decision is taken that has a material impact on the CGIAR System.

- 9.13 The CGIAR Board shall establish a standing CGIAR Nominations Committee, whose Terms of Reference shall be made publicly available.
- 9.14 The CGIAR Board may establish other committees of the CGIAR Board, and ad-hoc working groups and task teams, as it deems appropriate to carry out its work.

Article 10. Center Compliance with CGIAR Board Decisions

- 10.1 In the event that a Center does not fulfill its responsibilities as described in Article 5, or is not compliant with a decision of the CGIAR Board made within the scope of the CGIAR Board's functions as described in Article 8, the CGIAR Board may take such actions as it deems appropriate, within the parameters described herein, in consultation with the CGIAR Council. In any such case, the first action of the CGIAR Board shall be to consult with the Center's Board to discuss necessary remedial actions. The CGIAR Board shall allow reasonable time for the completion of remedial actions. If the two parties cannot agree, steps and procedures outlined in the dispute resolution mechanism approved by the CGIAR Board shall be followed.
- 10.2 Where the failure of a Center to fulfill its responsibilities relates to its performance in the CGIAR Portfolio, the action that may be taken by the CGIAR Board may include taking corrective actions as provided under funding agreements with Centers, as well as suggesting to the CGIAR Council to exclude such Center from the funding of CGIAR Research, and/or the withholding of current funding under the CGIAR Portfolio concerned in accordance with applicable agreements and/or request termination of recognition as a CGIAR Research Center in accordance with Article 4 hereto.
- 10.3 Where the failure of a Center relates to other matters, and the Center's Board is unable or unwilling to take the necessary remedial actions, the action that the CGIAR Board may take may include:
- recommending to the CGIAR Council, the exclusion of the Center from consideration for future funding
 - withholding current funding (to the extent allowable within any applicable agreements or contracts)

- c) requesting termination of recognition as a CGIAR Research Center in accordance with Article 4.

10.4 The CGIAR Board may not restrict a Center's right to secure funds outside the CGIAR Trust Fund or any other Center rights not conferred by virtue of recognition as a CGIAR Research Center. The CGIAR Board may not withhold a Center's right to discontinue recognition voluntarily.

Article 11. CGIAR Office

The CGIAR Office, headed by the Executive Managing Director, shall be responsible for the day-to-day operations of the System Organization, for supporting the CGIAR Council, and the CGIAR Board, and for facilitating integration and collaboration within the Integrated Partnership.

Article 12. Executive Managing Director

12.1 The Executive Managing Director is the executive director of the System Organization.

12.2 The Executive Managing Director provides coordinated leadership to the Integrated Partnership and is responsible for the System Organization's day-to-day operations.

Funding of the CGIAR System Organization shall be made in accordance with the overall financial plan for the CGIAR System. Funding shall include:

- b) funding from other sources as approved by the CGIAR Board and determined to be consistent with the purpose of the CGIAR System.

Article 15. Amendments

15.1 Amendments to this Charter may be proposed to the CGIAR Board, by any member of the CGIAR Board, by any member of the CGIAR Council or by any Center.

15.2 Amendments to this Charter shall be adopted by:

- a) the CGIAR Board
- b) two-thirds majority of Centers
- c) the CGIAR Council

Article 16. Dissolution

16.1 The CGIAR Board, in consultation with the CGIAR Council, may determine that the CGIAR System Organization is no longer able to function effectively and may adopt a resolution dissolving the CGIAR System Organization.

16.2 The States that are parties to the International Organization Agreement shall also be consulted prior to any decision to dissolve the CGIAR System Organization.

16.3 The CGIAR System Organization shall remain operative and not be dissolved until such time as the dissolution has been agreed to in accordance with this Charter and the CGIAR System Framework and for such an additional period as might be necessary for the orderly cessation of the CGIAR System Organization's activities and the disposition of its property.

16.4 In case of dissolution, the unencumbered funds of the CGIAR System Organization, subject to conditions attached to these funds, shall be returned to the original Funders, or with the original Funders' agreement distributed to organizations having purposes similar to those of the CGIAR System Organization.

16.5 Other net assets of the CGIAR System Organization shall be distributed to the Centers or to organizations having purposes similar to those of the CGIAR System Organization, as may be determined by the CGIAR Board.
